POLICIES & PROCEDURES

POLICIES

- All Vendors must be self-contained.
- Vendors must provide a list of materials (items to be sold, size of tent, generators, etc.)
- All activities and premiums/ handouts must be pre-approved by the BB&T Center and the City of Sunrise.
- All vendor promotions must be contained to designated space
- ABSOLUTELY NO banners, lawn signs, or stickers are permitted in the flowers, plants or attached to light
 posts, without written permission from the BB&T Center
- NO posters or banners may be affixed to the arena (inside or outside the building) without written permission from the BB&T Center
- Absolutely NO firearms, alcohol or tobacco permitted on the property

PROCEDURES

- On event day enter through Gate 5 of the BB&T Center
- Vendors must arrive to the property by 1:00 pm at the latest and be set-up, ready-to-go by 4:00pm
 on event date (If you arrive after this time, you will not be permitted to enter the property due to
 safety regulations)
- Upon arrival you will be instructed to you proper location
- All vehicles must drive a maximum 5 miles per hour or less in the event area.
 We strongly recommend having a ground member walk in front of the car to guide to its final location
- Vendors are responsible for providing your own equipment (i.e. tent, table, chairs, extension cords, collateral, etc) unless otherwise arranged
- Please do not take other vendors places. If you have question, please reach out to your BB&T Center contact
- Any pre-approved vehicles must remain parked in the location until 9:45pm at the earliest.
 BB&T Center reserves the rights to have vehicles remain parked in the location until it's deemed that the vehicle can be moved safely
- Please leave your area clean, the way you found it, and throw away any trash accordingly
- The BB&T Center is not responsible for any items or equipment left behind, this includes signage
